### THREE-DAY RIGHT TO CANCEL

You, the buyer, have the right to cancel this contract within three business days. Or, you may, if you wish, comply with the contractor's instructions on how to return the goods at the contractor's expense and risk. If you fail to make the goods available to the contractor, or if you agree to return the goods to the contractor and fail to do so, then you remain liable for performance of all obligations under the contract.
